



INSURANCE ATTESTATION - RENUNCIATION OF CLAIMS  
INSURANCE AGAINST BODILY ACCIDENTS

With regard to the insurance policy n° 45.045.747, subscribed by the Université Libre de Bruxelles (U.L.B.), ETHIAS, rue des Croisiers 24 in 4000 Liège (Belgium), guarantees the bodily accidents that might happen to the students, P.H.D. students and the researchers who have paid their registration or insurance premium to U.L.B. during their studies everywhere in Belgium or in foreign universities, as part of mobility programmes as well as during visits, periods of instruction or research, made under the responsibility of the University, all over the world, as well as on the way going and coming back from these activities. ETHIAS participation is complementary to the legal allowances of the mutual insurance system.

GUARANTEES' SUMMARY FOR POLICY n° 45.045.747

A. TREATMENT AND FUNERAL COSTS

- medical treatments present on the list of tariffs of the INAMI (National Institute for Illness and Invalidity Insurance) : 2 x its tariffs;
- dental prosthesis: 991,57 € with a maximum of 247,89 € per tooth;
- glasses frames: 61,97 € - lenses: full refund;
- medical treatments not present on the tariff list of INAMI: 247,89 €;
- funeral costs: 1.239,47 €;

- cost of transport: 495,79 €;
- search and repatriation costs: 2.478,94 €


B. CONTRACTUAL INDEMNITY


- death capital:
  - 12.394,68 € for single students,
  - 49.578,70 € for married students and single students parent of a child as well as for the philosophical degree students and researchers;
- permanent total invalidity capital: 148.736,11 €; cases of permanent partial invalidity are solved proportionally.

# INSURANCE ATTESTATION - RENUNCIATION OF CLAIMS INSURANCE FOR CIVIL LIABILITY

## STUDENTS, PHILOSOPHICAL DEGREE STUDENTS AND RESEARCHERS

---

With regard to the insurance policy n° 45.072.897, subscribed by the Université Libre de Bruxelles (U.L.B.), ETHIAS, rue des Croisiers 24 in 4000 Liège (Belgium), guarantees the civil liability of the **students**, **P.H.D. students** and the **researchers** who have paid their registration or insurance premium to U.L.B., on the basis of the laws and regulations of Belgium or other countries in this matter, for material or corporal damages caused to third persons, due to errors, negligence, omissions, imprudence or others on their part, during their studies everywhere in Belgium or in foreign universities, as part of mobility programmes, as well as during periods of instruction or research **all over the world** under the responsibility of the University.  
The civil liability of the students, P.H.D. students and researchers is not guaranteed on the way to and from the University.

The amounts covered are set as following:

- 5.000.000,00 € for bodily damages;
- 2.500.000,00 € for material damages, except with regards to damages caused to the goods lent during period of instruction for which the guarantee is limited to 25.000,00 € per casualty.

The insurance is subject to the following specifications:

1. the cover has only a complementary value and will only apply after any other policy covering the same persons has been applied;
2. are excluded from the insurance the damages to the goods and properties owned, rented, inhabited, used or held by the students.

Moreover, it is said that, during the instruction periods organised by the University, the guarantee of policy 45.072.897 is also worth for **directors of studies** (external to the personnel of the U.L.B.).


This guarantee extension is only worth in case of lacks or after any intervention of another insurance from which the director of studies could benefit and specially, their professional civil liability insurance.

ETHIAS renounces to any potential claim against the management staff and the employees of the companies in which those instructions and researches are conducted, with the exception of malevolence.


